The need to complete a treatment plan has been fully explained to me. Also, I understand that clinical results may vary depending on my response to laser and my compliance with pre and post treatment instruction. I have followed all pre-laser requirements previously provided to me and I understand and will follow the recommendations provided here for post treatment care of my skin, which have discussed with me.

Just as there are benefits to the procedure proposed, I understand that this procedure also involves risks and possible healing (down time) excluding laser toning/soft peel which is typically a no downtime procedure. I understand that serious complication is rare but possible. Common CURAS peel side effects include temporary redness and mild 'sunburn like effects; that may last few hours to a day or more. Pigment changes (light or dark spot on the skin) or prolonged redness lasting 1-3 months or longer may occur. Other potential risks include itching, pain, bruising, infection, scarring, and swelling. Laser light can cause eye damage and provided protective eyewear must be worn during treatment. Also, I will keep my eyes closed during treatment. I consent topical and or local anesthesia as needed, which involved risks of anesthetic drug reactions and complications.

The procedure, as well as potential benefits and risks, have all been explained to my satisfaction. I have had all my questions answered to my satisfaction. I freely consent to the proposed treatment.
